Wangsu CDN Pro EULA

Before you use the CDN Pro service provided by Wangsu Technology Co., Ltd. (hereinafter referred to as "Wangsu Technology" or "We"), Please carefully read this Wangsu CDN Pro User License Agreement (hereinafter referred to as "the Agreement"). If you disagree with all the terms of this agreement, please do not use the CDN Pro service. By using the CDN Pro service, you agree to accept all the terms of this agreement.

1、Product Description

CDN Pro is an advanced version of the CDN (Content Delivery Network) content distribution network platform, which is built on the global acceleration node of the network. Through the load balancing, content distribution, scheduling, and other functional modules of the central platform, users can obtain required content nearby, reduce network congestion, improve user access response speed and hit rate, improve user access quality, and reduce origin pressure.

At the same time, CDN Pro is an edge distributed Serverless Nginx platform that provides users with programmable CDN interaction services based on accelerated global content distribution. With CDN Pro, users can quickly build personalized business systems, sink business applications to the edge, reduce business development delivery cycles, achieve efficient and seamless integration between CDN and software business development lifecycle, and help accelerate and expand websites and applications worldwide.

2、Licensing

According to the terms and conditions of this agreement, Wangsu Technology hereby grants you a paid, non-exclusive, non-transferable, reproducible, and modified license to use CDN Pro. You can search for CDN Pro in the AWS Marketplace.

When purchasing CDN Pro services, you must submit an order request and confirm the order information in accordance with the relevant procedures and rules published on AWS Marketplace website. After the order is submitted, the submitted information cannot be modified in any way.

3、License Termination

This agreement shall continue to be valid until terminated by Wangsu Technology in writing. If you violate any of the terms of this agreement, your right to use CDN Pro will automatically terminate without further written notice from Wangsu. Upon termination of this agreement, you must stop using CDN Pro and destroy all CDN Pro services owned or controlled by you, otherwise you will bear

all legal liabilities.

4、 Disclaimers

1. CDN Pro is provided without any warranty, express, implied, or any other form, and you must bear the risk of using CDN Pro yourself.
2. Under no circumstances shall we be liable to you or any third party for any losses (including, but not limited to, loss of business profits, business interruption, or loss of business information) caused by the use or inability to use CDN Pro, even if we have been informed that such losses may occur. Under no circumstances shall Wangsu Technology be liable for any direct, indirect, incidental, consequential, special, or punitive damages, whether the claim is based on warranty, contract, tort (including negligence), or other reasons.
3. We shall not be responsible for any delay or non-performance of our obligations under this Agreement due to any reason beyond our reasonable control, including natural disasters, labor disputes, or other industrial disturbances, electrical or other power failures, utility or telecommunications failures, earthquakes, storms, or other natural factors, blockades, embargoes, riots, government actions or orders, terrorist acts, or wars.
4. You can only use CDN Pro services within the scope permitted by the laws of the People's Republic of China (including laws and regulations) and this agreement. If you do not comply with the corresponding terms or policies, we can suspend or stop providing services to you.

5、 Legal Responsibility

1. You agree that any risks arising from using CDN Pro are at your own risk.
2. You agree that all losses and legal liabilities arising from the illegal use of CDN Pro will be borne by you, and have nothing to do with Wangsu Technology.
3. You guarantee that all content within the acceleration node provided by CDN Pro meets the requirements of the "Internet Information Service Management Measures" of the People's Republic of China and other laws, regulations and normative documents, and other countries' relevant legal requirements. The following contents are not included in the accelerator node:
 - (1) Information and content that pose a threat to national security;
 - (2) Promote information and content such as violence, crime, war, terrorism, militarism, Nazi ideology, and national hatred;
 - (3) Obscene, low-level, and obscene information and content;
 - (4) Games, information, and content that are harmful to the healthy growth of young children;
 - (5) Information and content that infringe upon others' intellectual property rights, trade secrets, privacy rights, and other legitimate rights and interests;
 - (6) Other information and content that violate social public morality and public order and good

customs;

(7) Other information and content that conflict with Chinese laws and regulations.

4. You agree that the resources and services provided by CDN Pro should be used legally, including but not limited to:

(1) Comply with the relevant laws, regulations, administrative rules, and other legal norms of the People's Republic of China and the place where the service is used.

(2) Do not infringe upon others' intellectual property rights or trade secrets; Not infringe upon the legitimate rights and interests of others; Do not violate social and public morality.

(3) When required by laws, regulations, or national authorities, you should cooperate with Wangsu Technology to provide website information to the government and national authorities. Wangsu Technology can report the above information to the relevant government authorities on its behalf.

5. You agree that all losses caused by your improper use of CDN Pro to Wangsu Technology will be borne by you in accordance with the law.

6、 Intellectual Property

The intellectual property rights of CDN Pro are independently owned by Wangsu Technology. Except for the rights and licenses expressly granted in this Agreement, you do not acquire any ownership or license of copyright, trademark rights, patent rights, trade secrets, or any other intellectual property rights as a result of this Agreement. All information related to CDN Pro is trade secrets and confidential information of Wangsu Technology, and is protected by relevant laws and regulations of the People's Republic of China.

7、 Not to be used for illegal or prohibited purposes

When using the CDN Pro, you must not use the CDN Pro for any illegal purpose or use prohibited by the terms of this agreement.

8、 Retention of rights and ownership

CDN Pro reserves all rights not expressly granted to you in this agreement. CDN Pro reserves the right to update this agreement at any time, and only needs to publish it on the Wangsu Technology website without obtaining your prior consent and without further notice. The updated content should take effect immediately upon publication. You can check the latest version of the user license agreement at any time by visiting the Wangsu Technology website. If you continue to use CDN Pro after the update takes effect, it will be deemed that you have accepted the new terms.

9、 Version upgrade

Whether CDN Pro will provide version upgrade services in the future will be determined by Wangsu

Technology.

If Wangsu Technology agrees to upgrade the version, unless there is a replacement user license agreement after the upgrade, this agreement will still apply after the upgrade.

10、 Law Application and Dispute Resolution

This agreement is governed by the laws of the People's Republic of China. In case of any dispute arising from the signing, performance, or interpretation of this Agreement, both parties shall strive to resolve it through friendly negotiation. If consultation fails, either party has the right to submit the dispute to China International Economic and Trade Arbitration Commission for arbitration in accordance with its arbitration rules in effect at the time of filing the arbitration.
